1. Rental of Trailer.

Lessor agrees to rent to Lessee, and Lessee agrees to rent from Lessor, the following trailer:

2. Deposit.

A \$300 Refundable deposit is required at the time of rental. The deposit will be returned within 3 business days of the trailer being returned in the condition and cleanliness it was rented.

3. Rental Period.

4. Rental Fee.

6. Insurance.

Lessee agrees to maintain insurance on the towing vehicle with the trailer being towed covered on said insurance. Lessee agrees to provide proof of insurance to Lessor at the time of rental.

7. Condition of Trailer.

Lessee agrees to return the trailer in the same condition and cleanliness as it was at the time of rental, with normal wear and tear excepted. Lessee shall be responsible for any damages to the trailer caused by Lessee's negligence or misuse and will be responsible for cleaning fees if needed.

8. Default.

If Lessee fails to return the trailer on the agreed-upon date & time, Lessee shall pay Lessor a late fee of \$_____ per day until the trailer is returned. If the Lessee fails to return the trailer after 3 days, the Lessor may repossess the trailer without notice and the Leasee will be obligated to pay the late fees and any court costs incurred.

****9. Indemnification.****

Lessee agrees to indemnify and hold harmless Lessor from all claims, liabilities, damages, and expenses arising out of or in connection with the rental of the trailer.

****10. Entire Agreement.****

This Agreement constitutes the entire agreement between the parties and supersedes all prior or contemporaneous communications, representations, or agreements, whether oral or written.
